#### How we store your personal information

#### Your information is securely stored.

We will hold paper copies of any information for a period of no more than seven years and all expired records will be disposed of securely. All paper records are kept within a locked office and we keep all digital records on password secured computers to which only authorised staff have access. Your data protection rights
